RE: Mandatory Pre-Bid Meeting: Notes/Drawings

1. **Floor Patching:** Floor patching shall be the responsibility of the Contractor. Typical asphalt spalling areas were pointed out in the walk-through and it was noted that the Contractor was to accept the floor condition as is.
2. **Post Hole Patching:** Patching of post holes shall be the responsibility of the Contractor. Partially fill holes with a sand material and then cap off hole with a material compatible with the Artificial Turf.
3. **Artificial Turf Price per SF:** To add quantities during construction. \$____/SF.
(example-to install turf at ends of fields in 2' deep soccer goals similar to the existing goals)
4. **Drawing Revision dated 11/14/16:** This drawing replaces the drawing issued during the Mandatory Pre-Bid and the one in the Project manual.

1. ALL WORK MUST CONFORM TO LOCAL, COUNTY AND STATE REGULATIONS AND STANDARDS. THE CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING ALL NECESSARY PERMITS AND APPROVALS FROM THE APPROPRIATE AGENCIES.
2. LAIWORK SHALL BE COMPLETED WITHIN THE SPECIFIED TIME FRAME. DELAYED COMPLETION DUE TO ANY CAUSE OTHER THAN UNUSUAL WEATHER SHALL BE PENALIZED.
3. CONTRACTOR SHALL MAINTAIN ACCESS TO ALL ADJACENT PROPERTIES AND UTILITIES AT ALL TIMES. ANY OBSTRUCTION SHALL BE IMMEDIATELY REMOVED.
4. ANY WORK BEYOND THE SCOPE OF THE AGREEMENT SHALL BE QUOTED AND APPROVED BY THE CLIENT PRIOR TO COMMENCEMENT.
5. THE CONTRACTOR SHALL OBTAIN AND MAINTAIN ALL NECESSARY INSURANCE COVERAGE, INCLUDING LIABILITY AND WORKERS COMPENSATION.
6. THE CONTRACTOR SHALL BE RESPONSIBLE FOR THE PROTECTION OF ALL EXISTING UTILITIES AND STRUCTURES. ANY DAMAGE SHALL BE IMMEDIATELY REPORTED AND REPAIRED AT THE CONTRACTOR'S EXPENSE.
7. MATERIALS AND METHODS USED SHALL BE OF THE HIGHEST QUALITY AND IN ACCORDANCE WITH ALL APPLICABLE STANDARDS AND SPECIFICATIONS.
8. THE CONTRACTOR SHALL MAINTAIN A NEAT AND ORDERLY WORK SITE AT ALL TIMES. ALL DEBRIS AND EXCESS MATERIALS SHALL BE REMOVED DAILY.
9. CLIENT, PUBLIC AND PROPERTY DAMAGE: IN THE EVENT OF ANY DAMAGE TO CLIENTS, PUBLIC OR PROPERTY, THE CONTRACTOR SHALL BE RESPONSIBLE FOR THE FULL REPAIR AND REPLACEMENT OF THE DAMAGED AREA.

2. I understand that the Owner reserves the right to reject this Bid, but that this Bid shall remain open and not be withdrawn for a period of sixty (60) days from the date prescribed for its receiving. The period for acceptance of bid may be extended by mutual agreement between Bidder and Owner.

The Bidder, if awarded the contract, hereby agrees to commence work under this contract on or before a date to be specified in a written Notice to Proceed from the Owner and to fully complete work as specified. The Bidder also acknowledges and agrees to the Owner's right to assess liquidated damages as specified.

If written notice of the acceptance of this Bid is mailed or delivered to the undersigned within sixty (60) days after the date set for the receiving of this Bid, or at any other time thereafter before it is withdrawn, the undersigned shall execute and deliver the Bid Documents to the Owner in accordance with this Bid as accepted, and will also furnish and deliver to the Owner the Performance Bond, Labor and Material Payment Bond, and

proof of insurance coverage, all within ten (10) days after personal delivery or any deposit in the mails of the notification of acceptance of this Bid.

5. Notice of Acceptance or request for additional information may be addressed to the undersigned at the address set forth in Item 6 below.

6. The names of all persons interested in foregoing Bid as principals are:
