GENERAL INFORMATION

All bidders **must** use our form for submitting their bid. All bids must be sealed and marked in the lower left-hand corner "**BIDS – VEHICLE EQUIPMENT AND INSTALLATION**" with opening date and time. Late bids will not be opened. Bids will not include State Sales Tax or Federal Excise Tax.

Records showing successful bidder and prices quoted will be placed on file and may be examined upon request. If contract is awarded to someone other than lowest bidder, a note of explanation will appear in the bid file and Commission Minutes. Use of trade names and numbers shall be interpreted as establishing a standard of quality and shall not be construed as limiting competition.

DISQUALIFICATION OF BIDS

Bids may be disqualified before awarding of the contract for any of the following:

1. Failure to mark envelope as required.
2. Failure to sign or notarize the bid document.
3. Failure to include requested information, samples when specified or other details of the bid.

METHOD OF AWARD

The award will be made to the lowest responsible bidder meeting specifications for each item bid. It is not the policy of the Shelby County Commission to purchase on the basis of low bid only. Quality, conformity with specifications, purpose for which required, terms of delivery, and past service and experience are among the factors that may be considered in determining the responsive bidder.

The Shelby County Commission reserves the right to award separate contracts for each item, each product, or any combination of products if in the best interest of the Shelby County Commission. Upon awarding of this contract and bid the Shelby County Commission reserves the sole right to end said contract at their sole discretion.

CONTRACT PERIOD/PRICING

The period of this contract will be for one (1) year from date bid is awarded. This contract may be renewed for up to three (3) years from the initial award date upon the agreement of both parties.

IMMIGRATION LAW


By signing this contract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama. Specifications for Shelby County Sheriff's Office 2024 Marked and Unmarked Sheriff's Office Vehicle Equipment and Installation

The Shelby County Sheriff's Office shall have the sole right to determine if all requirements have been met.

The winning bidder must be ready to start installation of all vehicles within 30 days of notification that they have been awarded the bid for these vehicles and within 30 days of delivery and receipt of any future vehicles and equipment for the vehicles. This will be contingent upon delivery of vehicles and delivery of all emergency equipment from the manufacturers; the Sheriff's Office will provide projected delivery dates to the bidder as provided by vehicle manufacturers upon request.

Installer must be able to complete a minimum of 3 vehicles per week from the start date. If the winning bidder fails to deliver complete services during this established time frame punitive damages will be assessed. If the project is not complete by the third day past the estimated end date, a two percent reduction in the total project cost will be deducted from the final bill. In addition for every seven days following that the project is not complete another two percent (cumulative) reduction in the total project cost will be deducted from the final bill.

I. Light Bar

The light bar and all mounting hardware must be provided, installed, consist of all LEDs , and must meet the following specifications:

a. Make:

b. Model:

NXT Blue/White dual color front and side modules with alleys, and Blue/Amber dual color rear modules with T/ A

The light bar must be configured so that all blue LEDs will activate with an independent switch. The blue LEDs must also be capable of activating either the front LEDs (including front angled LEDs) or the rear LEDs (including rear angled LEDs) with independent switches). These specifications should be met with a three position slide switch included in the light bar control head. Position one must activate the rear of the light bar only, Position two must activate the rear and front of the light bar and Position three must operate the entire light bar takedowns, and alleys. Position three must also activate the siren. The traffic advisor must be capable of operating the light as Arrow Left, Arrow Right, Center Out and Flash with the split amber portion of the light bar modules to the rear which must be blue/amber split.

The rear of the light bar must be capable of flashing the left blue and right blue in an alternating pattern with an independent switch, commonly referred to as a rear flasher.

The LED take down lights must be on an independent switch.

The right alley light must be on an independent switch.

II. Secondary Lighting

Secondary Lighting will include the following LED lightheads:

Mpower 4" Quick Mount Lightheads will be mounted on both sides of rear license plate, both sides of the GoRhino pushbar at 45 degree angles, 2 on each running board at the front and rear of step, and on the rear bumper under each taillight housing. Intersector Under Mirror Lights will be mounted under mirrors. Nforce Single 12 LED Light will be mounted inside rear side cargo windows. Nforce Single 9 LED Light will be mounted in push bumper. Nforce rear interior bar will be mounted on to rear hatch. Mpower 3" Quick Mount Light will be mounted on rear D pillars.

III. Siren

A siren with an external speaker (mounted to the front of the vehicle) must be provided, installed and operational. Emergency Equipment Installation Specifications

Type of Wires:

All wiring shall be GXL high temperature automotive wire unless noted otherwise. All wires should be color coded and a wiring diagram provided upon request.

Running of Wires:

All wiring shall be continuous runs without splices and/or butt connectors unless noted otherwise.

Fusing of Wires:

All wiring shall be properly fused and/or Circuit breakers used. Fuses/Circuit Breakers shall be rated at 125% of amperage draw and mounted as close as possible to the power source. A 150 amp master reset circuit breaker will be mounted under the hood to provide constant power to a console mounted fuse panel for accessories which require constant power. This fuse panel will also include a grounding terminal block. An ignition fuse panel shall also be provided for appropriate ignition sources.

Encasing & Routing of Wires:

All wiring shall be encased in split wire loom, routed away from heat and sharp objects. Grommets used where needed and/or required and properly secured. All wire will be neatly tied and secure. All holes drilled into vehicle will be properly sealed to ensure weatherproofing. Wire will be out of the way of any equipment that maybe adjusted and not interfere with any moving parts in vehicle. Wherever possible wiring should be routed along with the vehicle manufacturer's wiring harness. No wiring shall be run on the floorboard underneath the factory carpeting unless otherwise noted.

Power Wires:

All power points will be taken directly from Battery Auxiliary Power Point.

Ground Wires:

All ground wires shall be connected to factory grounding studs/bolts unless noted otherwise.

Mounting of Equipment:

All of the equipment mounted shall be out of the Airbag Deployment Zone and easily accessible by user of equipment. Components shall be installed with quick disconnect connectors to allow for ease of replacement or repair.

Manufacturers Guidelines:

All installations shall be performed per manufacturers' specifications and/or instruction sheets provided with equipment.

Labor Warranty:

All labor must be warranted for a minimum of 1 year from the initial installation date or match the manufacturer's product warranty term whichever is greatest.

Uniformity:

All vehicles shall be equipped and installation performed identically to the others as per specs provided by the specific agency. Any deviations of specs will require a written request and approval from such agency.

Insurance:

Vendor must maintain a minimum of \$1,000,000.00 Garage Keepers Liability Insurance along with Workman's Compensation Insurance and able to be bonded.

Experience:

Vendor must have a minimum of 5 years experience installing emergency equipment and provide a minimum of 3 references of similar contracts to include similar scope and size. Vendor shall have EVT certification of emergency vehicle installations. All certifications must be on hand and available upon request of department.

Inventory:

Vendor must maintain inventory levels to enable off the shelf repairs or replacements of any defective equipment.

Repairs:

Vendor must provide repair of defective equipment within 48 hours of request by customer. Vendor must also diagnose and make appropriate repairs without leaving vehicle disabled waiting on parts.

Sub-Contracting:

Vendor must use company provided employees for all phases of the equipment installations. Sub-contracting will be allowed with agency permission for emblem, decal, striping and numbering installation.

Purchases by other Governmental agencies

Any entity of Shelby County Commission, Shelby County Board of Education, or municipality may purchase from this bid.

Location of Work to be Performed:

New vehicles will be delivered to the Shelby County Sheriff's Office by the manufacturer/dealership. All work provided by the vendor as described throughout this bid will be performed at the Shelby County Sheriff's Office impound building or at an established business location within, or adjoining, Shelby County, Alabama. The impound building is designed to accommodate up to four vehicles at a time with garage style roll-up doors on two sides. The building is climate controlled with amenities including restroom, electricity, water and 50 gallon air compressor.

Deadline for Performance:

1. The Shelby County Sheriff's Office will order new vehicles periodically. Once a new vehicle order has been placed, the vendor awarded this contract will be notified of the make, model and number of vehicles ordered. The vendor will also be notified of any equipment changes or deviations from the standard configuration as described in this bid. The Shelby County Sheriff's Office will provide vendor with a purchase order at that time and all necessary equipment will be ordered by the vendor. It will be the responsibility of the vendor to track all of these orders and follow-up on any items back-ordered. The vendor will make the Shelby County Sheriff's Office aware of any back-orders or discontinued items as soon as practically possible. The vendor can request an extension of the order period. The Shelby County Sheriff's Office will make the determination of whether to extend the order period.
2. Upon notification to the vendor that all new cars have been received by the Shelby County Sheriff's Office, the vendor will have 45 days (weekdays) to complete the installation of all equipment and accessories for 15 cars or less. Each additional new vehicle will add three additional days to the completion date.
3. The Shelby County Sheriff's Office will also purchase vehicles from existing dealership inventories periodically. Once a vehicle(s) has been purchased, the vendor awarded this contract will be notified of the make, model and number of vehicles purchased. The vendor will also be notified of any equipment changes or deviations from the standard configuration as described in this bid. The Shelby County Sheriff's Office will provide the vendor with a purchase order at that time and all necessary equipment will be ordered by the vendor. It will be the responsibility of the vendor to track all of these orders and follow-up on any items back-ordered. The vendor will have 60 days to order and receive the equipment specified. The vendor will make the Shelby County Sheriff's Office aware of any back-orders or discontinued items as soon as practically possible. The vendor can request an extension of the

order period. The Shelby County Sheriff's Office will make the determination of whether to extend the order period.

4. The vendor will have 45 days (weekdays) to complete the installation of all equipment and accessories for 15 cars or less. Each additional new vehicle will add three additional days to the completion date.
5. Once all equipment and accessories have been received by the vendor, payment may be made to the vendor for that portion of the contract (not to include the labor or installation payment until said work has also been performed).
