

CONSUMER CONFIDENCE REPORT PUBLICATION AND DISTRIBUTION GENERAL CONDITIONS AND SPECIFICATIONS

This bid is for the design, production, folding, and mailing of Shelby County Water's Consumer Confidence Report for 2024.

Specifications:

Size 25.5" x 11" Flat, with final fold to 8.5" x 5.5"

60 lb. white offset paper

It is a full-color document with 4/4 (bleeds)

Two full pages, front and back

- Document will be mailed out to approximately 13,500 customers
- 1,300 hardcopies will be delivered to Shelby County Water Services for additional distributions. These hardcopies need to be batched/bundled in sets of 50 or 100.
- Vendor must have the ability to mail pieces 3rd presort standard, using vendor's postal indicia for 3rd class mail and should include costs to meet USPS postal requirements for automated mailing (i.e., ink jetting name, address, postal barcode, tabbing, etc.)
- Bidders shall include all data preparation, including deduping and address corrections to the list provided by Shelby County Water.
- The mailing list will be provided in Excel format to the vendor after the bid is awarded.
- After the bid is awarded, the CCR data will be provided to the vendor in Word or PDF format.
- Price should include layout and design
- Upon receipt of the CCR data, the awarded vendor shall present a design to Shelby County Water within 3-5 business days.
- Shelby County Water will approve the final design within 3-5 business days of the vendor providing it.
- The brochure must be mailed and postmarked by or before **May 24, 2024**. Hardcopies are to be delivered to Shelby County Water by **May 29, 2024**.
- Please include a schedule of Production
- Vendor must provide proof of customer mailing to Shelby County Water no later than **May 29, 2024**.
- Postage will be billed to Shelby County by the vendor after the mailing occurs
- A W-9 and E-verify will be required before the bid is awarded. We request that you submit a completed W-9 and E-verify documentation with your bid packet. If you do not include the W-9 and E-Verify with your bid and your bid is to be awarded, Shelby County Water Services will contact you by the email provided in your bid packet and request the completed W-9 and E-Verify be submitted within 3 business days.

Steps to provide your E-Verify

- a. If you **do not have any physical employees in the State of Alabama**, you may submit a signed statement on letterhead in place of the E-Verify.
- b. If your company hasn't already, enroll in E-Verify at e-verify.gov
- c. If you are newly enrolling, you will have an opportunity at the end to print an MOU (Memorandum of Understanding) or check to see if your company printed and saved their MOU when they established the account. If you don't have the MOU, follow step d.
- d. You can Log into your E-verify account. Go to Company. Select Edit Company Profile. This will show your information. Print this page as proof of enrollment.
