WHEREAS, the Shelby County Commission requested bids for the Custom Reactivation/Replacement of GAC Media at the South Water Treatment Plant, and

WHEREAS, the Shelby County Commission recognizes the importance in optimizing the selection in carbon filter media, the critical nature of this media in the water treatment process, the media’s role in future regulatory compliance, and the significant costs implications, which the Commission finds warrants in the interest of the public good, welfare and health, utilizing in addition to and including the general powers and authority otherwise granted to the Commission, the bid law exemptions afforded to water treatment facilities pursuant to Section 41-16-51(b7), Code of Alabama in order to simultaneously evaluate the efficacy and efficiency of multiple media types and reliability of service by multiple vendors; and

BE IT RESOLVED, the Shelby County Commission hereby awards contracts to both responsive bidders namely Carbon Activated Corporation and Calgon Carbon Corporation in accord with their respective bids as follows:
