Sealed bids for INMATE COMMISSARY SYSTEM/SERVICES and items will be received in the office of the Chief Financial Officer, Shelby County Administration Building, 200 West College Street-Room 125, Columbiana, Alabama 35051 until 2:30 P.M., September 17, 2024, at which time bids will be opened publicly and read. The County Commission reserves the right to reject any or all bids and to waive informalities in awarding this bid to the lowest responsive bidder. Bidders are to state that bids submitted are firm and that no claims for errors will be made after bids are opened and subsequent thereof. **GENERAL INFORMATION**

All bidders **must** use our form for submitting their bid. All bids must be sealed and marked in the lower left-hand corner "**BIDS – INMATE COMMISSARY SYSTEM/SERVICES**" with opening date and time. Late bids will not be opened. Bids will not include State Sales Tax or Federal Excise Tax.

Records showing successful bidder and prices quoted will be placed on file and may be examined upon request. If contract is awarded to someone other than lowest bidder, a note of explanation will appear in the bid file and Commission Minutes. Use of trade names and numbers shall be interpreted as establishing a standard of quality and shall not be construed as limiting competition.

**DISQUALIFICATION OF BIDS**

Bids may be disqualified before awarding of the contract for any of the following:

1. Failure to mark envelope as required.
2. Failure to sign or notarize the bid document.
3. Failure to include requested information, samples when specified or other details of the bid.

**METHOD OF AWARD**

The award will be made to the lowest responsible bidder meeting specifications for each item bid. It is not the policy of the Shelby County Commission to purchase on the basis of low bid only. Quality, conformity with specifications, purpose for which required, terms of delivery, and past service and experience are among the factors that may be considered in determining the responsive bidder.

The Shelby County Commission reserves the right to award separate contracts for each item, each product, or any combination of products if in the best interest of the Shelby County Commission. Upon awarding of this contract and bid the Shelby County Commission reserves the sole right to end said contract at their sole discretion.

**CONTRACT PERIOD/PRICING**

The period of this contract will be for one (1) year from date bid is awarded. This contract may be renewed for up to three (3) years from the initial award date upon the agreement of both parties.

**IMMIGRATION LAW**



### **Bid Purpose**

Shelby County is issuing this bid in order to ensure that we are offering the most recent technology at the lowest cost possible through our inmate commissary system.

### **Background**

- Shelby County is a 556 bed detention facility housing both male and female inmates.
- Shelby County's average daily population from 7/1/23 – 6/30/2024 was 481.
- Shelby County currently uses Kimble's Commissary with commission rates as follows:
  - Commissary 45%
  - Video Visitation \$.10
  - Email 10%
  - SMS 10%
- Shelby County currently provides commissary two times per week with delivery on Tuesday and Friday.
- Delivery is implemented by employees of the commissary vendor
- Current commissary order limit is \$60.00 per store. Inmate's family/friends can order one additional "care pack" per store in addition to the inmate's spending limit.
- Current Commissary list with pricing is attached
- Report of Total Items ordered in June 2024 is attached
- Monthly Sales Report for July 2024 is attached

### **Successful Bidder's Requirements**

1. The Shelby County Jail shall maintain managerial and fiduciary control and responsibilities of the inmate commissary service.
2. The vendor's commissary services must integrate with Hexagon On Call Records, our current Jail Management System, and make every effort to integrate with any future Jail Management System used by Shelby County. All costs associated with the integration will be the sole responsibility of the vendor.
3. The vendor's commissary services must integrate with NCIC inmate telephone system and make every effort to integrate with any future inmate telephone service provider. All costs associated with the integration will be the sole responsibility of the vendor.

4. Any equipment to complete commissary services including but not limited to, dorm kiosk, public kiosk, booking kiosk, computers, printers, check printers, MICR toner for check printers, mail/document scanners, wireless networks, wiring, software, etc. is the sole responsibility of the vendor.
5. Vendor must replace the existing dorm kiosks and 2 portable kiosks currently being used in the facility. There are currently approximately 20 Dorm Kiosks and 2 Portable Kiosks but the addition of 44 beds may require 1 to 2 additional kiosks. All kiosks must be capable of providing the following
  - Commissary ordering
  - Access to account balances
  - Access to mail received by USPS and documents scanned by Shelby County jail staff
  - Ability to file grievances, medical requests and provide staff communication with the inmates
  - Display inmate handbooks and other documents
  - Announcement Screen for posting information
  - Provide an email option between inmates and their friends and family with the capability of attaching pictures. Emails and images must be accessible to the inmate for a period of at least 120 days from the date received. Emails and images must be accessible to Shelby County for at least a period of 3 years from the date received.
  - Provide Remote Visitation with scheduling options. All remote visitation recordings must be maintained for a minimum of 3 years from the date of the visit.
6. 2 Booking Kiosk Requirements
  - Allow inmates to deposit any money they have on their person at the time of booking at no cost to the inmate
  - Capable of taking bills, coins, credit/debit cards
  - Capable of detecting counterfeit money
  - Ensure secure transactions protecting Shelby County against fraud and theft of credit card information
  - All booking kiosk deposits will be handled by the commissary vendor and the vendor will be responsible for any discrepancies that are unable to be resolved.

7. Lobby Kiosk Requirement

- Simple to use requiring no assistance or information be provided by facility staff
- Capable of accepting bills and credit/debit cards for deposits to inmates' accounts
- Capable of detecting counterfeit money
- Provide receipt to the depositor
- Provide customer service number for questions or concerns about transactions
- All lobby kiosk deposits will be handled by the commissary vendor and the vendor will be responsible for any discrepancies that are unable to be resolved.

8. Vendor must provide a web based program that is browser agnostic, which allows assigned jail staff to receive and respond to inmate grievances and inquiries.

9. The vendor's commissary service must provide a way of scanning and attaching mail received by USPS and/or documents scanned by jail personnel to send to inmates

10. The vendor's commissary service must provide an email option for an inmate to send and receive emails.

11. Vendor must provide an option for inmates to transfer funds from their commissary account to the inmate telephone account at no cost to the inmate or Shelby County.

12. Vendor must provide option for adding funds to an inmate's account by the facility at no cost to the inmate. (facility checks, cash at booking, etc.)

13. Vendor must provide an option for debit card releases as well as issuing checks. The commissary vendor will be responsible for providing checks and debit release cards to the facility.

14. When an inmate is released the system must allow for the release of the balance on the inmate's commissary account as well as the inmate's phone account.

15. The vendor must ensure that Shelby County will not be responsible for any counterfeit money accepted by their kiosk machines or fraudulent credit/debit cards used.

16. Vendor's software must be able to identify the housing location of an inmate and allow access from kiosks located in that location only to prevent messaging between inmates in different locations within the jail.

17. Vendor's software must be able to allow store restrictions based off of an inmate's housing location.

18. Commissary services are to be provided from the vendor's offsite warehouse
19. The Shelby County Jail must approve all commissary items and be able to customize the commissary items offered.
20. Prices for commissary items may not be higher than prices for comparable items offered for retail.
21. Vendor must provide a sample menu of proposed commissary items and pricing with bid response.
22. Vendor is responsible for securing and paying all federal and state taxes, local licenses, permits and fees required for the delivery of commissary services.
23. All food containers and packaging must be received dated at least 2 weeks before the expiration date.
24. Vendor must provide family and friends an option to purchase items for inmates without actually adding funds to the inmates account. Family and friends currently have an option of purchasing pre-packaged items through the vendor's website for delivery to an inmate.
25. Vendor must provide their employees to pass out store, issue credits for items not received and any other issues arising from store operation.
26. Vendor must issue credit for any items that are deemed undeliverable. If an inmate is released, a credit must be issued for the store items and the items will remain the property of the vendor.
27. Vendor must provide inmates without access to a kiosk an option for ordering commissary through the inmate phone vendor.
28. Vendor must provide a designated person to handle any requests or problems with store operations or features of their services.

### **Technical Requirements**

All networking infrastructure including internet connection, routers and cabling must be provided by the vendor. Portable kiosks should be able to utilize a wireless access system also provided by the vendor.

Video visitation recordings shall be kept and maintained for a term of at least one year.

All access to the commissary and visitation administration should be web based and browser agnostic.

### **Installation, Training and Support**

Vendor shall provide all necessary training on the commissary services and accounting software to the staff.

Vendor shall provide instruction to current inmates on the process of ordering commissary items, kiosks, etc.

Vendor must provide 24 hour technical support and respond within 24 hours to the facility if necessary.

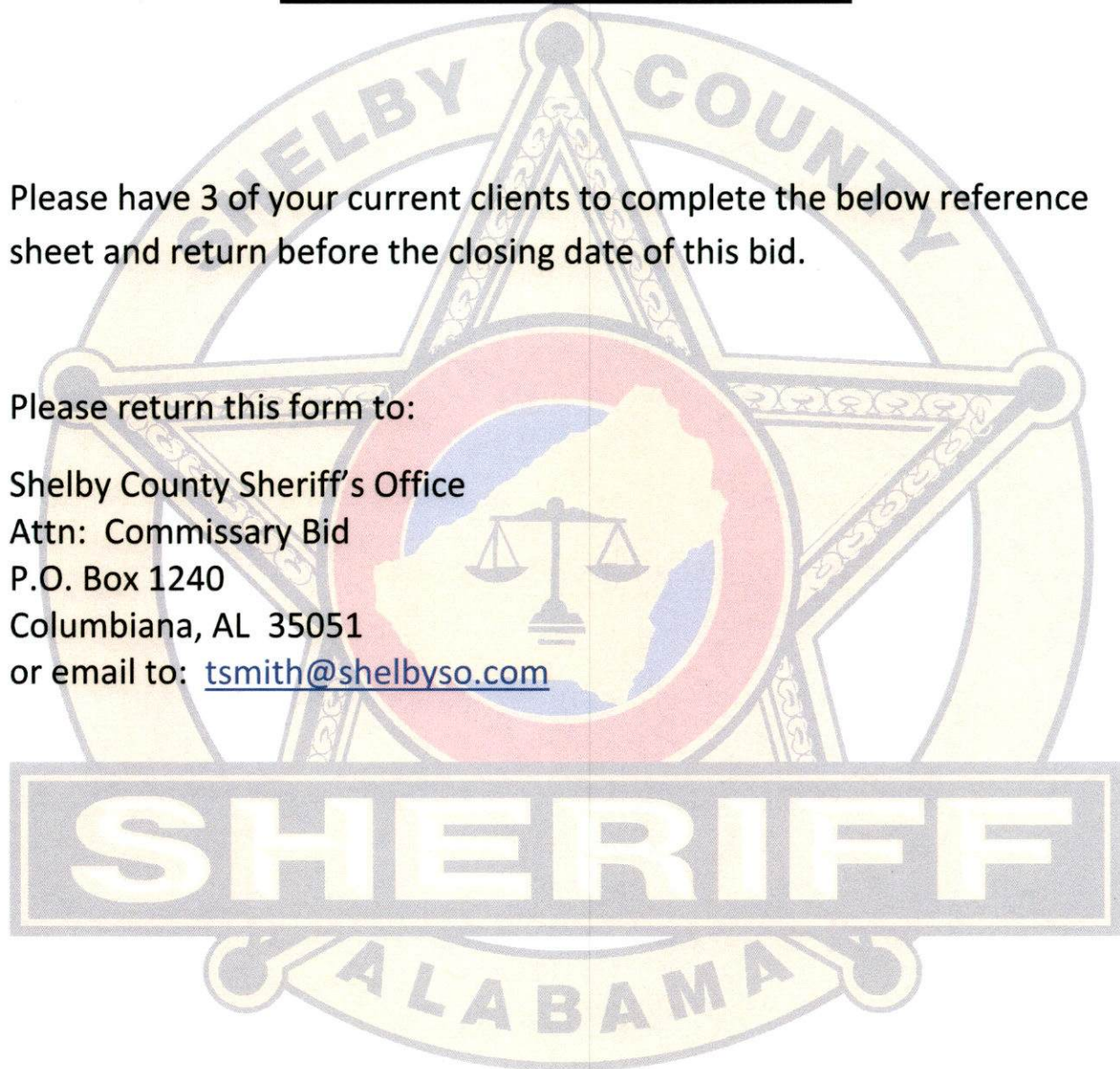
