Sealed Bids for **Sod** will be received by the County Manager at the County Administration Building located at 200 West College Street in Columbiana, Alabama 35051 until **2:00 p.m.** local time on **Thursday, September 1, 2022**, at which time Bids will be opened publicly and read. The Shelby County Commission reserves the right to reject any or all bids and to waive informalities in awarding this bid to the lowest responsive bidder. Bidders are to state that bids submitted are firm and that no claims for errors will be made after bids are opened and subsequent thereof. **GENERAL INFORMATION**

Shelby County desires to receive bids for the following:

1. Submit a bid for sod as described to be delivered to various sites within Shelby County, Alabama. Bid prices should be per pallet for 1-7 pallets delivered and 8 or more pallets delivered.
2. Pallet Return: If there is a deposit for pallets, this should be listed as a separate item.

Sod shall be fresh, well-rooted sod free of weeds, disease, insects, and other grasses. The sod shall be machine cut with clean edges to a uniform thickness with 1 ½" of topsoil. Sod shall be delivered and unloaded on 50 square yard pallets, and/or 70 square yard mini rolls.

Shelby County reserves the right to reject any or all bids. Bidders are required to be licensed in accordance with State Law.

Bid prices shall be good for one year after award of bid and may be extended if mutually agreed upon by County and bidder for up to three years.

All bids must be sealed and marked in the lower left-handed corner **"BID – Sod Bid"** with opening date and time. Late bids will not be opened. Bids will not include any Local, County, or State Sales Tax. Records showing successful bidder(s) and prices quoted will be placed on file and may be examined upon request. If contract is awarded to someone other than the lowest bidder, a note of explanation will appear in the bid file and the Commission Minutes.

## **DISQUALIFICATION OF BIDS**

Bids may be disqualified before awarding of the contract for any of the following:

- A. Failure to mark envelope as required;
- B. Failure to sign or notarize the bid document;
- C. Failure to include requested information for other details of the bid; or

## **METHOD OF AWARD**

The award will be made to the lowest bidder meeting specifications. It is not the policy of the Shelby County Commission to purchase on the basis of low bid only. Quality, conformity with the specifications, purpose for which required, terms of delivery, and past service and experience are among the factors that may be considered in determining the responsive bidder.

The Shelby County Commission reserves the right to award this contract for each if in the best interest of the Shelby County Commission. Upon awarding of this contract and bid, the Shelby County Commission receives the sole right to end said contract at their sole discretion.

## **IMMIGRATION LAW**

By signing this contract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom.

## **OPEN TRADE**

By signing this contract, vendor agrees that it is not currently engaged in, nor will it engage in, any boycott of a person or entity based in or doing business with a jurisdiction with which the State of Alabama can enjoy open trade.

Please provide your bid response in triplicate, one original and two copies.

Bids will not include State Sales Tax or Federal Excise Tax.
