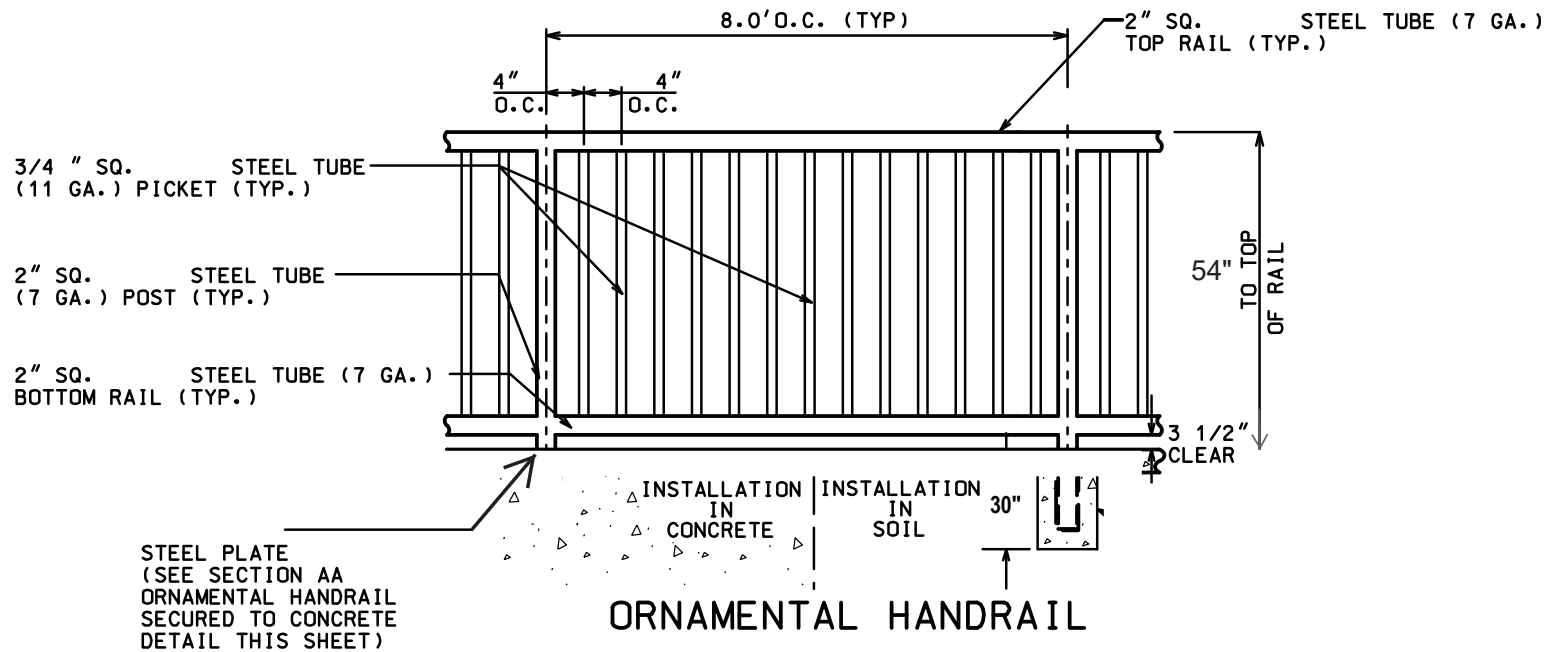

  - Handrail will be 54" to top of rail instead of 58"
  - Installation in soil will be 30" instead of 14"
  - Anchoring will be located on top of existing bridge deck instead of top of existing bridge curb
- See attached revised PROPOSAL FORM to submit all bids for the Cahaba River Bridge Pedestrian Railing Project. Revised form includes the option for the owner to self-perform installation.

**NOTE: HANDRAIL TO BE INSTALLED IN APPROXIMATELY 16' SECTIONS WITH A 2 INCH GAP BETWEEN EACH SECTION**



APPLY SHOP PRIMER TO ALL ORNAMENTAL HANDRAIL COMPONENTS.

APPLY HIGH PERFORMANCE COATING EPOXY INTERMEDIATE AND POLYURETHANE TOPCOATS TO PRIME COATED SURFACES. COLOR: BLACK. COMPLY WITH COATING MANUFACTURER'S WRITTEN INSTRUCTIONS. PRIMER AND HIGH PERFORMANCE COATING APPLICATION SHALL COMPLY WITH REQUIREMENTS IN SSPC-PA 1, "PAINT APPLICATION SPECIFICATION NO.1: SHOP, FIELD, AND MAINTENANCE PAINTING OF STEEL."
