All bids must be sealed and marked in the lower left corner "**BID – General and State Certified Concrete**" with opening date and time. Late bids will not be opened.

Use of trade names and numbers shall be interpreted as establishing a standard of quality and shall not be construed as limiting competition.

**Prices must be valid for a period for one (1) year from date of bid award.** This contract may be renewed for up to three (3) years from the initial award date upon the agreement of both parties

All pricing shall include delivery to Columbiana, Alabama - FOB to 505 Highway 70, Columbiana, AL 35051

### **DISQUALIFICATION OF BIDS**

The Shelby County Commission reserves the right to award separate contracts for each item, each product, or any combination of products if in the best interest of the Shelby County Commission.


### **IMMIGRATION LAW**
