The Shelby County Commission reserves the right to reject any or all bids and to waive informalities in awarding this bid to the lowest bidder. Bidders are to state that bids submitted are firm and that no claims for errors will be made after bids are opened and subsequent thereof. GENERAL INFORMATION

All bidders must use our form for submitting their bids. All bids must be sealed and marked in the lower left corner "**BID – PISTOLS AND ACCESSORIES**" with opening date and time. Late bids will not be opened.

Records showing successful bidder(s) and prices quoted will be placed on file and may be examined upon request. If contract is awarded to someone other than lowest bidder, a note of explanation will appear in the file and Commission Minutes.

Use of trade names and numbers shall be interpreted as establishing a standard of quality and shall not be construed as limiting competition.

Prices must be valid for a period of one (1) year from date of bid award. This contract may be renewed for up to three (3) years from the initial award date upon the agreement of both parties.

DISQUALIFICATION OF BIDS

Bids may be disqualified before awarding of the contract for any of the following:

- A. Failure to mark envelope as required;
- B. Failure to sign or notarize the bid document;
- C. Failure to include requested information or other details of the bid
- D. Failure to include shipping costs within your bid pricing.

METHOD OF AWARD

The award will be made to the lowest responsive bidder meeting specifications. It is not the policy of The Shelby County Commission to purchase on the basis of low bid only. Quality, conformity with specifications, purpose for which required, terms of delivery, and past service and experience are among the factors that may be considered in determining the responsive bidder.

The Shelby County Commission reserves the right to award separate contracts for each item, each product, or any combination of products if in the best interest of the Shelby County Commission.

Please include one original bid response and two copies in your submittal.

Pistol & Accessories Bid

Bid Purpose

Shelby County is issuing this bid solicitation in order to obtain pricing for the purchase of new pistols and additional accessories. This bid solicitation also seeks to receive a "trade-in" price for the Glock 17 Gen 5 pistols currently deployed and in use by the Shelby County Sheriff's Office (hereafter referred to as SCSO), in order to reduce the price of the new pistols. The new pistol selected for use by the SCSO is a Glock 17MOS, Gen 5, 9MM, with fixed sights, with 3 magazines and a box. The bid seeks two different "package" prices to include the aforementioned pistol and the equipment listed in Appendix "A." The only difference in the two packages is the holster selection. There are also accessory items listed that we are also seeking a bid price for. These accessory items are listed below Option A and Option B. The trade-in pistol which is currently in use by the SCSO is a Glock 17, Gen 5, 9MM with fixed sights and has three magazines. The SCSO currently has 147 sworn deputy sheriff employees and it is the goal of the SCSO to upgrade the duty pistols assigned to sworn personnel. Instructions

In addition to any requirements by Shelby County, all potential bidders must read and acknowledge all portions of this bid. Potential bidders are required to sign and initial where indicated on this document. Initials are required at the end of numerous paragraphs, as indicated by a short blank highlighted line. Bidders are also required to complete the last page of this bid proposal which is a pricing sheet for the item(s) corresponding in Appendix "A."

Statement of Expectations

The SCSO is requesting bids to purchase, in bulk, Glock 17MOS pistols, Gen 5, 9MM, with fixed sights, 3 magazines and a box. This pistol must be delivered with the equipment listed and specified in the two different options as noted in Appendix "A" of this bid. Equipment includes, Trijicon Red Dot optic, waterproof seal, Ameriglo Suppressor height sights. The two options in Appendix "A" include two different holster considerations. Pricing for these packages will be good for a one year period from the award date of this bid. A contract may be awarded to the successful bidder for two additional years, only if agreed to by both parties. Items will be purchased on an "as needed" basis for the duration of the contract period. This solicitation for bid outlines our expectations of a potential retailer/supplier regarding pricing, customer service, turn-around time on back-ordered items, etc.

Appendix "A" describes specific items and related equipment which make up the two different "pistol packages" the SCSO is seeking to purchase. Alternate product brand names shall not be accepted, unless agreed by the Shelby County Sheriff's Office. The SCSO reserves the right to accept or reject all or any part of a bid, and to accept the bid or bids that are the most advantageous to the Sheriff's Office and its employees.

The SCSO requires that all items specified be purchased from a single supplier. Bids will be evaluated on cost, the ability of the bidder to meet the specifications and requirements listed in this document, and bidder performance and reliability. Suppliers will be required to acknowledge that they have read, understand, and agree to, abide by and fulfill the expectations listed.

Bid Pricing

Prices quoted for each individual item will be effective beginning one year period from the award date of this bid, and will remain in effect for one calendar year. Thereafter, the vendor/supplier may adjust pricing on each year thereafter to only reflect increases in wholesale costs. However, the percentage of increase in bid price shall not exceed the percentage of increase in wholesale price for the bid item. In order for the bid to be extended, the price must be agreed upon by both parties. Should bid prices be adjusted, the supplier will be required to provide documentation showing an increase in wholesale prices from the previous calendar year on each item for which there was an increase in bid price.

There will be no hidden costs, and all bid prices will include any shipping and/or handling costs, either on the part of the manufacturer, vendor, supplier, or any other person/entity involved in the handling and transfer of merchandise.

Prices quoted must include the purchase amount for all items, and requirements as listed in Appendix "A" and in this document.

The winning bidder must agree to purchase the SCSO "used" Glock 17 Gen 5, 9MM, with fixed sights and 3 magazines at the price listed by the supplier on the Pricing Sheet. The "trade-in" amount will be deducted from the total amount of the pistol "package."

Customer Service

In addition to quality public safety equipment, the SCSO believes that customer service should be a priority for any company or corporation seeking to provide products to the Sheriff's Office. Therefore, to secure and maintain Sheriff's Office business, potential suppliers must agree to and abide by what have been identified as acceptable standards of customer service. Beyond the usual meanings of service, care, courtesy, and satisfaction, customer service shall include the aspects listed below.

The supplier will provide a business phone number that is answered during normal business hours. The supplier will designate a specific contact person(s) with whom Sheriff's Office employees may communicate directly regarding orders, problems, customer service, questions, etc. The supplier will provide the Shelby County Sheriff's Office with the contact person's name, business phone number(s), business email address, and fax number(s), whereby the designated representative may be contacted during normal business hours. Voice mail, answering machine, etc. must be provided for the designated contact person so that Sheriff's Office employees may leave a message for the contact person when unavailable and/or during non-business hours.

The supplier also agrees to provide a reasonable delivery time to the Shelby County Sheriff's Office. The preferred delivery time is within 90 days, and shall not be later than 120 days from the time of purchase.
